library materials? Collection Growth

Picton Branch collection size 17,951 5,026 items added 2015 system-wide (2,513 Picton)

Using the Items Method of collection growth:

18,000 items today + 1,800 unoccupied space + 2,200 added annually + 22,000 added over a period of 10 years + 2,200 unoccupied shelf space

Picton branch should have space for 46,200 items and is over-full at the current collection size of 17,951.







#### **Adult Fiction shelves**

- Too close together
- All adult items interfiled (mystery) for space saving
- Sightlines



## **Large Print Room**

Shelving too high (OPLG guidelines no higher than 60 inches) Elevator pathway prevents a comfortable sitting area **Demographics** predict increased use of Large Print





Children's area New collections (Family Learning Resource Centre and DVDs) both require additional space

Street parking only.

Limited parking for staff and courier delivery.

No children's program room - children's programs are held in the children's room, limiting access to library materials for other patrons

# Is there a children's washroom? Does it have child-size fixtures? Is the space large enough for an accompanying adult? Is the door to the washroom visible to the staff?

- Public Washrooms are too small – as a result change station in children's play area.
- No children's washroom
- Doors open into hallway which is dangerous
- Hallway is dark and narrow



## Is there sufficient seating and a variety of seating to accommodate users' needs?






## Are teens attracted to the building?



Teen programs have suffered as the Teen Room has become a multipurpose space.



Makerspace/community meeting room/ IT training lab/Teen Room





Multi-purpose space means that public access computers are inaccessible during programs, there is insufficient space to store supplies for programs, staff time spent re-arranging prior to events.

Teen book collection moved upstairs to ensure youth have access to the books, however, this means the books are far from where the youth are often using the library.

## Are there sufficient computers for public




Computers are spread throughout the building making tech help difficult. No space for one-on-ones. Limited space for laptop or tablet users.

- Bookkeeper








# Circulation desks Children's circulation desk is not child-friendly height Adult desk – no separate place for volunteers to call hold items

No staff lunchroom space or secure places for storage of personal effects.



- Children's room fireplace


## Does noise carry through the building?


Yes – frequent requests for quiet areas or quiet meeting rooms

Prince Edward County, CY - Age distribution





Table 4 Prince Edward County, CY – Age distributions by broad age groups and sex, 2011 Census

Age groups	Both sexes	Males	Females
0 to 14	12.2%	12.8%	11.5%
15 to 64	62.6%	62.7%	62.6%
65 and over	25.2%	24.5%	25.9%

In 2011, the percentage of the population aged 65 and over in Prince Edward County, <u>CY</u> was 25.2%, compared with a national percentage of 14.8%. The percentage of the working age population (15 to 64) was 62.6% and the percentage of children aged 0 to 14 was 12.2%. In comparison, the national percentages were 68.5% for the population aged 15 to 64 and 16.7% for the population aged 0 to 14.
