Planning – health & safety - hand sanitization stations have been now been set up in the smaller branches in addition to Wellington and Picton, already done.

Branches – Curbside service started Wednesday, May 20, 2020. Picton and Wellington are running this during 10 am to 4 pm Tuesday to Saturday. Ameliasburgh, Consecon, Milford and Bloomfield are running their regular branch hours.

Meeting Rooms – online zoom meeting bookings are dropping off as the groups are starting to meet outside with the nicer weather.

Programming – the website is continuing to change with the library, all the programming is on line via Facebook Live and Zoom substantially. Live Support online chat with our IT Staff, everyday 10 am to 4 pm, Monday to Saturday, continues. IT Resource Webinar 2x per week will be reduced to 1x per week, and replaced with more summer children's programming. The Health department has approved a Busker performing in the patio area, as well private family bookings for reading time.

The Board noted what an amazing job the library staff are doing in staying relevant, and in delivering online programming.

Computers – Awarded ESDC Grant for \$20,000 to purchase tough case lap tops that withstand moisture and can be wiped clean and used safely by patrons and staff.

Planning for the Future – planning for opening. Working with the health department, full face shields have been recommended and have been made by the IT Staff for all staff to wear on the floor when patrons are on site in addition to their face mask. Zoom meetings are held 2x per week with the CEO and all staff in open discussions about daily operations of the library.
